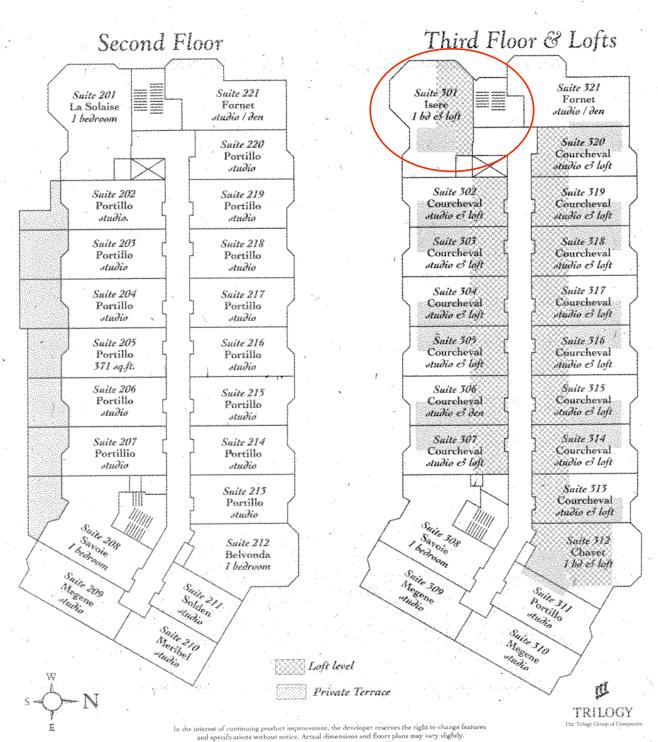

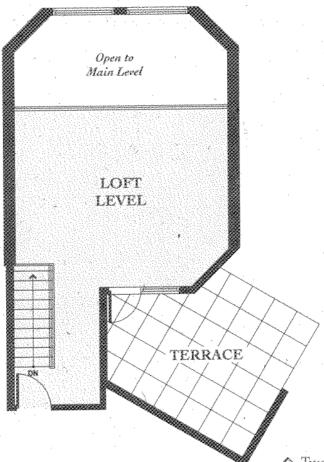
FLOOR PLAN

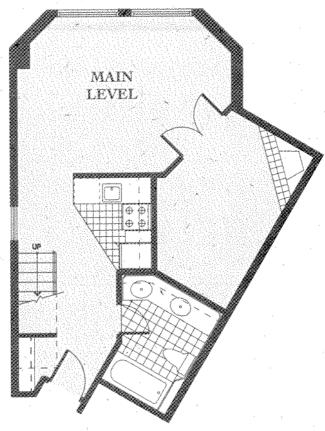
